The appropriate commission is being issued accordingly. This appointment requires the advice and consent of the Senate.

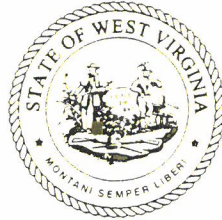
