Now Comes the West Virginia Radiologic Technology Board of Examiners (hereinafter "Board"), and hereby adopts the "Hearing Examiner's Recommended Decision," by Hearing Examiner Jack McClung, dated May 24, 2005, in its entirety, as if fully set forth herein.

Accordingly, the Board Orders as follows:

1. Effective immediately, the radiologic technology license of Andrea Smith is hereby REVOKED for a minimum period of three (3) years. Respondent shall not engage in the practice of radiologic technology whatsoever, either directly or indirectly, in the State of West Virginia during such period of REVOCATION.

2. Respondent shall pay to the Board the amount of Four Thousand One Hundred Sixty Nine Dollars (\$4,169.00). Such payment by Respondent shall represent the

costs incurred by the Board associated with the investigation and prosecution of Complaint Number 05-002, and the subsequent reimbursement to the Board thereof.

3. Respondent may not petition the Board for reinstatement of license, and the Board shall not consider any petition for reinstatement of license, until such time Respondent complies with all terms of the instant Order as provided herein.


